

## Fees, Payment Policy, & Insurance

**FEE FOR SERVICE:** We are “fee-for-service” providers. Our clients pay for their sessions on the same day they are seen in therapy. We do not bill directly to insurance. We can provide you with a receipt or “Superbill” that you can submit to your insurance company for direct reimbursement.

**INSURANCE:** Insurance companies vary in the services they cover (type of service, percentage they cover, and number of sessions per year). If you would like to be reimbursed for a portion of your services, it is your responsibility to check with your insurance company on what is available to you in your current plan. The following is information you may need to provide your insurance company when you call to check what services are covered and what percentage of the service is reimbursable to you. When calling, please remember that a “fee-for-service” provider is also an “out of network provider.”
